SUBJECT: Delay in Implementation of Administrative Claims for the  
Victims of Domestic Violence

The purpose of this release is two fold.

First there will be a delay in the implementation of the planned revision to the Schedule D-2- Allocation for Claiming of General Services Expenditures (DSS-2347-B) in the Automated Claiming System (ACS). This revision is to provide a mechanism for reporting administrative expenditures made for victims of domestic violence and to identify these costs for the available additional state funding when the local social services district exceeds its Title XX allocation.

The ACS change will not be ready until the April 1992 claim submission due in Albany by May 20th.

The revised Schedule D-2 will only impact those districts that have a Social Services Reporting Requirements percentage (or a Random Moment Study percentage for New York City) for the Victims of Domestic Violence (VDV) category. Therefore, in those districts that have an established percentage for (VDV) identified in SSRR/RMS% the State will manually track your January-March 1992 expenditures and VDV SSRR/RMS% to ensure your district receives the proper reimbursement. Some districts have directly identifiable costs (e.g. contract for hotline services) that would be claimed on the Identified Costs Line 2 of the Schedule D-2. The expenditures for these costs should not be claimed until their April, 1992 original claim submission.
